1. Call to Order

Mr. Mullowney called the meeting to order 7:00 p.m.

2. Adoption of Agenda

The Agenda with amendments was tabled for approval.

BE IT RESOLVED that the Agenda be adopted with item number 4 (b) (4) removed and the addition of 'Update Regarding Bell Island Waste Recovery Facility' under New Business, item number 6 (a). Carried Unanimously

3. **Review of Minutes**

The minutes from the previous meeting were tabled for review and approval.

4. **Committee Reports**

a. **Finance & Audit Committee**

Mr. Hickman delivered the ERSB Finance and Audit Committee report.

1. Board Expenditures

Board expenditures for the months of June, July and August 2019 were tabled for review and approval.

MOTION 2019-070 Moved By Mr. Hickman Seconded By Mr. Bailey

BE IT RESOLVED that ERSB adopt the Board Expenditures for June, July and August 2019 as tabled. Carried Unanimously

2. Incorporated Towns Payment Activity Report

The Incorporated Towns Payment Activity Reports for June, July and August were tabled for review. Mr. Hickman noted collections from incorporated towns is going well except for the Town of Aquaforte. Aquaforte is behind on its payments but did submit payment in July for the first six months of service in 2019.

3. Concept for Reduction of Service

Mr. Hickman noted that meetings were held with the Minister Municipal Affairs and Environment and department officials on September 11th, 17th and 24th to work out details regarding implementation of the directives. It is hoped, there will be a final decision in the near future.

4. Draft Budget 2020

The draft 2020 budget was tabled and a short discussion took place.

MOTION 2019-071 Moved By Mr. Hickman Seconded By Mr. Froude

BE IT RESOLVED that ERSB adopt the draft 2020 budget as tabled with the understanding that the response from the Minister of Municipal Affairs and Environment regarding the reduction of services to unincorporated areas as well as the outcome of the Provincial Waste Management Strategy review may have significant and unforeseen impacts on the Board's 2020 budget.

5. Regional Equipment Required – Towable Spreaders for Clarenville Transfer Station and Whitbourne Depot.

MOTION 2019-072 Moved By Mr. Hickman Seconded By Mr. Whalen

BE IT RESOLVED that ERSB purchase two (2) 1.4 cubic yard Towable Bulk Spreaders one each for the Clarenville Transfer Station and the Whitbourne Maintenance Depot at a cost of \$26,446 plus HST. Carried Unanimously

6. Recruitment – Manager Corporate Services

Previously, this position was held by Lynn Tucker. Mr. Craig Drover has been hired as the Manager Corporate Services.

7. Recruitment – Board Clerk and Outreach Coordinator

Mr. Hickman noted the Board advertised throughout September and received five resumes. The Selection Committee comprised of the CAO, Chair, Vice Chair and Chair of the Governance Committee hope to hold interviews next week.

8. Old Perlican Waste Recovery Facility Contract Extension

Mr. Hickman noted the Board contracts out operation of the Old Perlican Waste Recovery Facility. The contract ends effective September 30, 2019; however, the contract provides a one-year extension and the contractor for the facility is in agreement with extending the contract for a one-year team.

MOTION 2019-73 Moved By Mr. Hickman Seconded By Mr. Clarke

BE IT RESOLVED that ERSB offer a one-year extension for the management of the Old Perlican Waste Recovery Facility to September 30, 2020.

b. Strategy & Policy Committee

Mr. Whalen delivered the ERSB Strategy and Policy Committee report.

1. Clarenville Waste Collection Contract

A brief note was provided regarding the contract for the Clarenville area curbside collection service that expires at the end of the year. The contractor has agreed to a one-year extension that the contract provides.

MOTION 2019-74 Moved By Mr. Whalen Seconded By Mr. Bailey

BE IT RESOLVED that the ERSB exercise the option to extend the Clarenville waste collection contract and seek the commitment of communities to participate in the regional service to December 31, 2020. Carried Unanimously

2. Closure of Sunnyside Waster Recovery Facility for Winter 2019-2020

Mr. Whalen noted that the Sunnyside Waste Recovery Facility has a very low historical winter usage and it continues to decline since the Clarenville Transfer Station opened. Due to the high cost of snow clearing for this facility and very low usage it was decided to close the facility from mid-December to early April.

MOTION 2019-075 Moved By Mr. Whalen Seconded By Mr. Tilley

BE IT RESOLVED the ERSB close the Sunnyside Waste Recovery Facility over the winter months from Monday, December 16, 2019 to re-open Saturday, April 4, 2020. Carried Unanimously

3. Q2 Waste Operations Report

Mr. Whalen noted there were no disruptions to waste collections. Seven communities participated in the Community Clean-up. Eighteen communities participated in the Board's HHW mobile collection events. The Board continues to participate in the Electronic Products Recycling collection program at our facilities.

There was one regulatory visit at the Clarenville Transfer Station with no issues found. There were 12,391 visits to waste recovery facilities removing 2,379 metric tonnes. There was 3,348 metric tonnes of curbside waste including recyclables.

4. Provincial Waste Management Strategy Review Response from ERSB

Mr. Whalen noted the Board continues to work on its written response to the Provincial Waste Management Strategy Review and members will be provided a copy of the Board's response once finalized.

c. Governance Committee

Mr. Clarke delivered the ERSB Governance Committee Report

1. Update on Union Certification Process

The Board's management team continues to work with our labour relations advisor on this matter. At this time they are preparing for the collective bargaining process that is expected to begin very soon. Members will be kept updated regarding this process.

5. Correspondence

Letter to the Minister of Education Regarding School Recycling Program

As requested by members at the August meeting, the members were provided a copy of the letter sent to the Hon. Brian Warr, Minister of Education regarding the lack of available recycling programs for schools in the eastern region. To date ERSB has not received a response.

6. New Business

a. Update Regarding Bell Island Waste Recovery Facility

Ms. Dean, Manager Waste Operations and the Manager of Waste Management Infrastructure, Municipal Affairs and Environment, visited the site today.

After the site visit they met with representatives of the Town of Wabana to discuss mediating the Board's concerns with placement of the waste recovery facility at the former landfill site at Wabana.

RECOMMENDED ACTION:

It is recommended that Eastern Regional Service Board adopt the 2020 budget as tabled; however, members should understand that the anticipated response from the Minister Municipal Affairs and Environment regarding the reduction of services to unserviced roads/unincorporated areas as well as the outcome of the Provincial Waste Management Strategy review may have significant and unforeseen impacts on the 2020 budget.

MOTION:

BE IT RESOLVED that the ERSB Finance Committee recommend that the Board adopt the 2020 budget as tabled with the understanding that the response from the Minister of Municipal Affairs and Environment regarding the reduction of services to unincorporated areas as well as the outcome of the Provincial Waste Management Strategy review may have significant and unforeseen impacts on the Board's 2020 budget.

BACKGROUND/DISCUSSION:

- Consider an increase in the budget for Board remuneration/per diem \$10,000 above current budget amount of \$100,000. The Board has not increased the per diem amount since 2015.
- Staff salary costs an economic increase of 1.77% has been included.
- Staff salary costs all positions treated as filled as Board uncertain as to its service delivery areas for 2020.

- Staff salary costs regional waste operations has increased due to addition of one new position of casual site attendant at the Whitbourne Waste Recovery Facility; all positions considered filled with projected overtime included.
- Staff salary costs waste collections has increased due to addition of one labourer position being added to the Collections team. All positions considered filled and projected overtime included.
- For waste operations and waste collections, the remuneration may change as the Board enters into collective bargaining this fall.
- Benefits costs have decreased due to Workplace NL penalties ending for former employee and a decrease in the cost of the health and life benefits program.
- Transportation and Communications the costs for telephone communications has decreased due to current year's actual experience.
- Supplies no change.
- Purchased Services Administrative increased for legal expertise. We foresee additional legal costs following outcome of ministerial directives and for the collective bargaining process.
- Property, Furnishings & Equipment increased by \$5,000 overall to as computer licensing fees have increased. However, photocopier expenses decreased.
- Purchased Services Consultants No change and nothing budgeted for consulting services similar to prior years.
- Regional Operations & Waste Recovery Facilities Decreased significantly as the amount budgeted for fleet storage in Blaketown is no longer required and the Board will settle its lease payments for two grapple trucks purchased in 2011 in November 2019.
- Regional Transfer Station Clarenville Increased as the amount budgeted for vehicle maintenance and operations as per actual expenses in current year.
- Household Hazardous Waste Program Decreased to reflect actual program cost for 2019.
- Curbside Waste Collection Program No change
- Water/Wastewater Program Provincial government provided funding of \$80,000 for May 2019 through March 31, 2021 to continue this program.
- Fire Protection No change
- Reserves No funding included for reserves. The Board <u>may</u> need to use a portion of its reserves to buy out contracts following the Minister's decision regarding reduction of services to un-serviced/unincorporated areas.
- Capital ERSB Landfill closures \$300,000 is budgeted for the closure and remediation of the Bell Island landfill; however, to date the Board has not received funding notification from the Province. For Regional Equipment \$821,000 has been budgeted as the Board will need to replace two of its grapple trucks in the next several years. One grapple truck (approximately \$750,000) has been budgeted for 2020 and the other will be budgeted in 2021; however, the Board may decide to pay out the grapple trucks in a lease arrangement rather than purchasing them outright. In addition to the grapple trucks, \$30,000 has been included here for required maintenance at the Clarenville Transfer

Station; \$10,000 is budgeted for tools at the Board's new depot at Whitbourne; and 2 sanders/spreaders at \$15,500 each is required – one for the Clarenville site and the other for the Whitbourne site for winter maintenance.

 Revenue is projected to remain the same overall for 2020 based on YTD experience with slight increases in the Clarenville Transfer Station tipping fee and transportation revenue for Clarenville Transfer Station. Interest revenue is down slightly based on 2019 experience. The Regional Landfill Tipping Fee Derived has increased by \$679,544 due to the monies required under Capital ERSB to purchase/replace equipment.

OTHER CONSIDERATIONS:

- As members are aware the Minister Municipal Affairs and Environment has issued directives to the Board to cease mandatory waste collection services on unserviced roads/unincorporated areas. The Board continues to await an answer from the Minister in response to its implementation plan for these directives.
- The Board had requested a response by Friday, August 16, 2019 to meet the deadline of December 31st for its contractors to suspend service to the affected areas; to buyout contracts; and, most importantly to have the time to re-tender contracts so that remaining customers would have waste services for 2020.
- The response will most likely impact the Board's current operations and service areas. Therefore, the Board's budget will most likely be impacted by these changes.
- The cost of buying out the contracts is estimated to be \$600,000.
- The cost of contract termination can be paid for from operational reserves that were funded by all services users. This will mean that those that remain in the service areas then have to pay to rebuild those reserves.

It is recommended that the ERSB exercise the option to extend the current waste collection contract and seek the commitment of communities to participate in the regional service for an additional year.

MOTION:

BE IT RESOLVED that the Strategy & Policy Committee will recommend that ERSB exercise the option to extend the Clarenville waste collection contract and seek the commitment of communities to participate in the region al service for an additional year.

BACKGROUND:

The current contract for the Clarenville area curbside collection service will expire at the end of this year. The contract had two options to extend for one year at a time. One of the two possible extensions has been issued; therefore, this will be the last possible extension, if granted.

The individual pricing for this contract is the best we have been able to achieve in the most recent tendering. We do not anticipate going to tender will result in additional cost savings.

The performance of the contractor has been good with no substantial issues identified.

The main issue of concern is the commitment of the communities to remain in the regional service. In order to determine whether or not they want to remain a part of

the regional system will depend on the annual fee per household charged by the Board.

The challenge for the Board is that the annual fee cannot be set until the Board has a response from the Minister's office regarding the withdrawal of services on un-serviced roads/unincorporated areas.

If we intend to seek an extension then a commitment from the communities will be needed. Communities will not want to commit until they have the annual fee per household so that they fully understand the costs for their community.

The contractor has agreed to an extension if the Board determines this would be best for our communities and the communities are interested.

Does the Committee recommend:

- Starting the process to extend the waste contract;
- Or, go to tender?
- If extending the contract, will the annual fee per household remain at \$180 for 2020 for the Clarenville area?

OTHER CONSIDERATIONS:

Please note that following a response from the Minister's office regarding the ministerial directives of February and March 2019 may impact the Board's annual fee per household.

RECOMMENDED ACTION:

It is recommended that the ERSB close the Sunnyside Waste Recovery Facility over the winter months. Date of closure would be from Monday, December 16, 2019 to reopening on Saturday, April 4, 2020. Closure would be communicated by site signage, a letter being sent to the potentially impacted communities as well as ads in the local papers.

MOTION:

BE IT RESOLVED that the Strategy & Policy Committee recommend that ERSB close the Sunnyside Waste Recovery Facility over the winter months from Monday, December 16, 2019 to re-open on Saturday, April 4, 2020.

BACKGROUND:

The Sunnyside Waste Recovery Facility (WRF) has very low historical winter usage. Before the opening of the Clarenville Transfer Station the Sunnyside WRF would see about 60 to 74 visits a month for the months of January, February and March.

Since the opening of the Clarenville Transfer Station the annual usage at the Sunnyside WRF has continued to drop. The most significant drops are observed in the winter months of January through March. In 2019 the average number of visits for January through March was 36 visits a month. This equates to an average of <u>one visit every two hours</u>.

The significant reduction in usage is likely due to the extended hours available to the public at the Clarenville Transfer Station. The transfer station is open to the public 40 hours a week rather than the 16 hours weekly that the Sunnyside WRF is open.

In addition to the Clarenville Transfer Station, the Whitbourne Waste Recovery Facility is now operational and in close proximity for the public that historically used the Sunnyside facility.

Another very important consideration for the Sunnyside WRF is the high cost of snow clearing at the facility. For the winter of 2018 – 2019, the Sunnyside WRF snow clearing contract was the highest snow clearing contract awarded. The high cost of snow clearing and very low public usage resulted in a snow clearing cost of \$80.11 per client visit. This is not sustainable or fiscally responsible.

OTHER CONSIDERATIONS:

The Board may want to consider <u>permanent closure</u> of the Sunnyside Waste Recovery Facility as the public in the area has access to either the Clarenville Transfer Station and/or the Whitbourne Waste Recovery Facility.

When the Board determined where to locate its waste recovery facilities it was decided that the public should not have to drive more than 70 to 100 km to dispose of their bulk type materials. The decision to locate a waste recovery facility at Sunnyside was made before the opening of the Clarenville Transfer Station or the Whitbourne Waste Recovery Facility.

The Towns of Come-by-Chance and Sunnyside are located 22 kilometers from the Clarenville Transfer Station; therefore, they are well within the travel distance deemed acceptable. In addition the public in the areas between Whitbourne and Clarenville are within acceptable travel distances.

In addition the extended hours provided at the Clarenville Transfer Station makes this location much more accessible and appealing for the public.

The continuation of operations at Sunnyside Waste Recovery Facility is not fiscally responsible as:

- The cost to staff the site equates to \$35.00 per customer visit;
- The cost of snow clearing equates to an additional \$80.11 (plus HST) per customer visit during the winter months;
- These costs do not include the cost to maintain the road to the facility; the cost to maintain the waste recovery site; the cost to remove waste from the facility; etc.

The Eastern Regional Service Board (ERSB) would like to bring to your attention the lack of available recycling programs for schools in the Eastern region.

In 2009 the ERSB was given a mandate to ensure the efficient delivery of modern waste management services throughout communities in the Eastern region that includes the objective of reducing the amount of waste going into landfills by 50 percent.

Since 2014 the ERSB has been enthusiastically engaged in promoting and providing opportunities for schools in the Eastern region to recycle. At the start of the 2014-2015 school year, the MMSB, the School Board and the ERSB entered a MOU outlining the parameters of a three-year pilot program that included exploring the potential for schools to expand current recycling initiatives and to divert additional waste streams from our landfills. The overall goal being the promotion and support of modern waste management practices as a means of protecting the environment in Newfoundland and Labrador.

In 2017 following completion of the pilot project, ERSB provided suggestions to the School Board to assist in increasing the number of schools with access to recycling opportunities. In addition the ERSB communicated that we would be willing to provide recycling and waste collection services at all 29 schools in its service area and provided the annual cost for these services. However, the School Board determined this to be impossible; therefore, the ERSB and the School Board entered into another agreement for the next tender period whereby ERSB would provide waste and recycling collection at nine schools in total. Six of those schools were from the original pilot program plus one school for which the School Board didn't have a tender issued and two others mutually agreed upon.

ERSB was of the understanding that the School Board was interested in implementing recycling in its schools but needed more time to roll out the program in the Eastern region. We were told that the School Board was required to implement a recycling program in the Central region and that was a large project.

At every opportunity ERSB staff have communicated to the School Board that ERSB does not want to compete with private waste haulers by continuing to provide waste removal services at Eastern region schools. Participation in the pilot program and subsequent work has proven that recycling can be and should be done in schools.

Currently recycling in schools in the Eastern region includes paper recycling (offered at 60 schools in the greater St. John's area) and, collection of beverage containers under the MMSB beverage container program for which schools receive money.

The ERSB was disappointed in August 2019 when once again, school waste tenders for the Eastern region were issued without schools being provided the opportunity to recycle. Upon learning this, ERSB staff reached out to the Facilities Manager for the NL English School District responsible for the tenders and outlined the Board's concerns that include why recycling collection is not required in the tenders and wondering if the School Board is aware of the *Provincial Waste Management Strategy* and its current review.

The Facilities Manager indicated that recycling could be offered in a separate contract if it was requested by schools; however, no school administrator outside the greater St. John's area had requested a recycling program. However, ERSB and the MMSB have received several requests/concerns from schools throughout the Eastern region regarding the lack of recycling programs.

For the past five years ERSB has requested recycling programs be available to all schools in the Eastern region. Additionally we are surprised that for the past three to four years the Central region has offered recycling program at its schools and report the program as being very successful. In addition we understand that the Western region schools also participate in recycling. Therefore, we are perplexed as to why the School Board will not implement a recycling program in the Eastern region.

The ERSB has reached out to other areas and we understand that at this time the areas that adjoin the Eastern region such as the Bonavista and Burin Peninsulas also lack recycling opportunities at their schools.

The ERSB, comprised of 20 elected officials, and its staff have worked in good faith with the School Board with the understanding that both parties were working toward providing access to recycling for all schools in the Eastern region.

Due to the lack of progress in this initiative, the ERSB felt we had to bring this matter to your attention. The ERSB hopes that all parties can work together in fulfilling the objectives of the *Provincial Waste Management Strategy* and to provide a wonderful learning and environmental stewardship opportunity to schools in the Eastern region. Educating our children about the importance of recycling and the environment provides a path to a greener future. Hon.
